# GENERAL CONDITIONS OF SALE

## DÉFINITIONS

For the purposes of these General Terms and Conditions of Sale ("GTCS"), capitalized terms shall have the following meaning:

"AIDC": Refers to the shareholder company Aéroport International du Castellet with a capital of 2,500,000 euros, whose head office is located at 3,100, Route des Hauts du Camp - 83330 Le Castellet - France, registered in the Trade and Companies Register of Toulon under number 479 467 193

"GTCS": Refers to the present General Terms and Conditions of Sale.

"Formula 1 Grand Prix": Refers to the automobile sports competition organized annually by the "Groupement d'Intérêt Public Grand Prix de France - Le Castellet" at the Circuit Paul Ricard, located at 2760 Route des Hauts du Camp, 83 330 LE CASTELLET, adjacent to AIDC.

"The Airport": Refers strictly to the runway and terminal building and the infrastructure necessary for its use.

"The Customer": Refers to the customers or users of AIDC

"Parties": Refers to AIDC and the Customer together and to AIDC or the Customer individually

"The Services": Refers to all the services provided by AIDC

"MTOW": Maximum Take-Off Weight, this value is used for billing purposes, rounded up to the nearest ton.

« TAG »: Refers to "Touch and Go", which is the action of landing and taking off an aircraft on the runway without stopping.

« Assistance »: Refers to ground handling services for parking, securing aircraft, baggage assistance, airside escort and relations with ground operations.

## SCOPE OF APPLICATION

AIDC offers various services and sales of goods to its customers and users. As such, any provision of Services or sale of goods is subject to these GTCS, which prevail over any other document, with the exception of any specific contract expressly derogating from them. Any request and/or actual use of a Service therefore implies the buyer's unreserved acceptance of these GTCS. Any condition to the contrary opposed by the Customer will, therefore, in the absence of express acceptance, be unenforceable against AIDC, regardless of when it may have been brought to its attention. The GTCS may be modified at any time and without notice by AIDC, it being specified that the applicable GTCS are those in force. These GTCS include the rates, this text, and the appendices. No special condition may, unless formally accepted in writing by AIDC, prevail over these GTCS. The placing of an order by the Customer necessarily entails its waiver of any General Purchasing Conditions or of any provision contrary to these Conditions.

The fact that AIDC has not required the application of any right and/or clause of the GTCS, whether permanently or temporarily, shall in no way be considered as a waiver of the benefit of such right or clause.

## PRICES

All prices are quoted in Euros and are exclusive of VAT. Consequently, they will be increased by the applicable VAT rate. The prices invoiced are those published on the day of the operation.

The rates are available on site, on the internet on the website of the company Aéroport International du Castellet at the following address: <http://www.aeroportducastellet.com>.

**Events:** The Customer is informed that during the period from Thursday to Sunday inclusive, special financial and operational conditions are in place.

## CONDITIONS OF PAYMENT

Any payment made to AIDC shall not be considered as a deposit. The Customer may not, under any circumstances, even on the grounds of a claim, withhold all or part of the sums due, nor operate any compensation. Aeronautical fees are payable in full at the AIDC reception desk prior to departure.

## METHODS OF PAYMENT

Payment for Services invoiced by AIDC is due on the due date and shall be made in a single payment:

- In full, at the AIDC reception desk. Only credit cards from the **“Carte Blue,” Visa, Eurocard/MasterCard, and American Express** networks are accepted, and the customer explicitly acknowledges having the right to use them.
- by **French bank check or postal check** made out to:  
**Aéroport International du Castellet**
- by **SEPA Bank Transfer**  
For transfers originating from abroad, Customers are required to stipulate "charges to be paid by the payer".
- by **SEPA Direct Debit** on bank or postal account, by credit card on site or remotely.
- by **cash payment** (Euros) at the reception desk within the legal limits.
- For aviation fuel payments, **only the following cards** are accepted:

## PAYMENT DEADLINES

The deadline for payment of invoices is due on the date of receipt of the invoice, except in the case of special commercial agreements negotiated between the company and the customer. The non-contestation of the invoice 10 days after the date of reception by the Customer is considered as final acceptance of this one.

No discount will be granted for early payment (Article 2 de la law No 92-1442 du 31/12/1992).

## PENALTIES FOR LATE OR NON-PAYMENT

---

### GENERAL PROVISIONS - DELAY, LEGAL FEES, AND LITIGATION

Any invoice that has not been paid by the due date will result in a reminder letter being sent, which has the force of a formal notice.

#### **Penalties:**

In the event of non-payment on the due date, the Customer shall immediately owe interest on the amount still due on that date, at the legal interest rate set by the European Central Bank at its most recent refinancing operation plus ten (10) points. This interest shall be due by the mere arrival of the term, by operation of law and without the need for formal notice. It is due at the end of each month.

In such a case, the Customer shall also pay AIDC a fixed indemnity for collection costs of forty (40) euros, automatically and without further formality. If the collection costs are higher than the amount of this fixed compensation, AIDC may request additional compensation, with proof.

**Litigation:** In case of non-payment within the deadline and after sending a formal notice, the file is transmitted to the legal department, without prejudice to the two previous paragraphs. Collection costs and late payment penalties are to be paid by the Customer.

If, during a previous transaction, the Customer has failed to meet one of his obligations (notably default or delay in payment), a refusal to sell may be made unless the Customer provides satisfactory guarantees or cash payment.

## EXCEPTIONAL CLAUSES

---

### CANCELLATION OF ADVANTAGES

AIDC may, in the event of non-compliance with the legal deadlines for payment of an invoice, immediately and definitively cancel any commercial advantage granted to the Customer. Payments for which collection is ensured by legal action will be assigned to invoices in chronological order of issue.

## PRECAUTIONARY SEIZURE OF THE AIRCRAFT

AIDC may oppose a customer who is in default of payment obligations, the measures of seizure in accordance with the legal provisions in force.

Article L123-4 of the Civil Aviation Code:

*"In the event of non-payment or insufficient payment of airport charges, route charges, air traffic terminal dues or administrative fines imposed by the Airport Noise Control Authority, the aerodrome operator or the competent State administrative authority may, after having given the person liable for payment formal notice to regularize his situation, request the seizure of an aircraft operated by the person liable for payment or belonging to them from the judge of the place where the measure is to be implemented.*

*The order of the enforcement judge is forwarded to the air traffic authorities of the aerodrome for the purpose of immobilizing the aircraft. The order shall be notified to the debtor and to the owner of the aircraft where the debtor is the operator.*

The costs incurred by the seizure shall be borne by the debtor.

Payment of the sums due shall result in the release of the seizure. »

## RESERVATION CANCELLATION AND MODIFICATION POLICY

### RESERVATION CHANGES

The Customer may request a change in the reservation of his handling service, parking, or hangar rental via e-mail to [operations@aeroportducastellet.com](mailto:operations@aeroportducastellet.com), subject to availability and possibilities. No postponement will be accepted for the following year. If no change is made, the Customer shall make the rental under the original booking conditions or cancel according to the cancellation conditions set out below.

Any request to increase the duration of the rental will be made according to availability.

Any request to reduce the length of your rental is considered a partial cancellation and will be subject to the terms and conditions for cancellation and interruption of the rental provided below.

### CANCELLATION

In case of cancellation or modification of the reservation by the Customer, an amount will be retained according to the notice:

- Cancellation more than 48 hours before the reservation, no amount will be charged.
- Cancellation between 48 hours and 24 hours before the reservation, 50% of the service will be charged.
- Cancellation less than 24 hours before the movement, 100% of the amount of the service will be charged.

In the event of cancellation of the reservation by AIDC for reasons other than those provided for in the Force Majeure article below, subsequent to the validation of said reservation, AIDC will repay to the Customer, up to the amount of the total price of the services provided for in the context of the reservation, the sums received in respect of the various payments made by the Customer, by way of flat-rate, global and definitive compensation for the prejudice, if any, alleged by the Customer.

### UNUSED SERVICES

Any rental interrupted or shortened (late arrival or early departure) by the Customer will be charged in full and will not give rise to any refund.

- A company registration certificate less than 3 months old.

- A certificate of tax compliance issued by the Tax Administration and less than 3 months old.
- A 2.000 euros deposit refundable at the closing of the account.

The application to open a customer account implies the Customer's agreement to abide by our general terms and conditions of sale mentioned on the Price List.

## INTELLECTUAL PROPERTY RIGHTS

Any use, copy and/or dissemination of an element or attribute of intellectual property of any kind of AIDC, in any form and in any manner whatsoever, is strictly prohibited without the prior, express, written authorization of AIDC.

## PERSONAL DATA

The personal data is processed under the responsibility of the Castellet International Airport and is used for the management of air navigation management and control services as well as the other services provided for in the present GTCS, legal basis for processing. The recipients of this data are the Aéroport International du Castellet and its subcontractors located in the European Union. The data is kept for the duration of the contractual relationship and up to 5 years after its end.

In accordance with the applicable regulations, the Customer has the right to access, rectify, delete and port the data concerning them, as well as the right to oppose the processing for a legitimate reason, which they may exercise by contacting the data controller at the following email address : <https://www.aeroportducastellet.com/fr/contact/> or by mail to Aéroport du Castellet, RGPD, 3100 Route des Hauts du Camp 83330 LE CASTELLET (FRANCE).

Proof of identity may be requested prior to responding to the request and some requests may not be acted upon, such as if it would prevent the provision of services or meet a legal obligation.

The Customer is invited to first contact the Castellet International Airport amicably to exercise their rights, but they are informed that they have the right to lodge a complaint with the competent supervisory authority of their principal residence and in particular with the CNIL for French residents.

## FORCE MAJEURE

Neither Party shall be liable for any delay in the performance of its obligations or the exercise of any of its rights, if it demonstrates that such delay is due to a case of force majeure within the meaning of the provisions of Article 1218 of the Civil Code and/or of the case law in force.

## COURT OF LAW – LANGUAGE

Any dispute relating to the formation, interpretation, or execution of these GTCS will be submitted to the exclusive jurisdiction of the Commercial Court of Toulon. The present general conditions of sale are governed by French law.

In case of contradiction between the translated version of the GTCS and the French version, only the French version will be valid between the parties.

## PASSENGER TAX

This fee pays for the use of the airport's reception facilities.

**Fee per passenger (National, European, International) ----- 25,00 €**

- Passenger fees **are due** upon embarkation of passengers for any aircraft:
  - used for commercial purposes,
  - non-commercial with an MTOW of 2 tons or more.
- Passenger fees **are not due** by:
  - Crew members of the aircraft performing the flight,
  - Passengers of an aircraft making a forced return due to technical incidents or unfavorable atmospheric circumstances,
  - Passengers of an aircraft making a technical stopover,
  - Children under the age of two,
  - Passengers making a temporary stop at the airport and leaving on the same aircraft.

## EXTENDED AIRPORT OPENING HOURS (MINIMUM NOTICE REQUIREMENT: 24H)

Terminal and runway opening hours:

- ❖ Summer hours (France - local time): between 09:00 and 18:00
- ❖ Winter hours (France – local time): between 09:00 and 17:00

Outside of opening hours, access to the facilities is increased:

- **€200.00 per 30 minutes<sup>5</sup>**
- **€300.00 per 30 minutes between 9 p.m. and 7 a.m.**

The "departing" extension starts at the time of activation of airport services (Minimum 30 minutes before departure or at the request of the air operators);

The "on arrival" extension ends at the time of the departure of the crew from the terminal or at the activation of airport services (Minimum 1 hour in case of arrival before the opening time of the airport).

The "summer" and "winter" seasons are defined in such a way that the "summer" timetable begins on the last weekend of March, on the night of Saturday to Sunday, and ends on the last weekend of October on the night of Saturday to Sunday.
