DEFINITIONS

In the content of these General Terms and Conditions of sale ("G T & C"), terms in capital letters refer to the following meanings:

« AIDC »: Refers to the shareholder company ("AIDC") with a capital of 2,500,000 euros, head office is located at 3100 Route des Hauts du Camp - 83330 Le Castellet - France, registered in the trade and commercial register companies of Toulon under the number 479 467 193.

« Airport »: Refers strictly to the runway, the terminal building as well as all other infrastructure necessary for its use/ operations.

« The Customer »: Refers to the customers of AIDC

« Parties »: Refers to both The AIDC and the Customer and individually AIDC or the Customer

« Services »: Refers to all services provided by AIDC

« MTOW »: Refers to Maximum Take-Off Weight this value is used for invoicing and rounded up to the next ton.

APPLICABLE FIELDS

AIDC provides different products and services to its customers and users and therefore all services or products are subject to these G T & C which will prevail over other documentation, except in the presence of a valid contract. All requests and / or use of services are subject to GT&C. Failure to decline these GT&C, the customer will be held liable. AIDC reserves the right to modify and change the GT&C without prior notice from AIDC by stating the current GT&C in place. These later, include GT&C all tariffs, current text as well as annexes. No special condition will prevail over the GT&C except when made in writing on our part. When the customer confirms handling request he is therefore legally bound and waves his right to dispute the current GT&C of sale

Whereas AIDC has not required the application of a right and / or any clause of the GT&C, whether permanently or temporarily, cannot in any case be considered as a waiver of this right or clause.

PRICES / FEES

All prices are in Euros without taxes and excluding VAT. Therefore, the price will be subject to the additional VAT charges. The prices invoiced are as published on the day of the operation/service

CONDITIONS OF PAYMENT

All payment made to Aéroport International du Castellet, can't be considered as a deposit. The Client can't in any case or for any acclaimed reason retain all or part of payment nor claim any kind of compensation. All fees and charges are payable in full in advance at the Airport Reception prior to allocation of PPR agreement (prior agreement to land and take off prior to departure delivered by AIDC Operations).

METHODS OF PAYMENT

Payment of invoices issued for services provided by AIDC are payable on the due date in one in full:

- At the Airport reception. All major credit cards are accepted such as **Visa, Eurocard/MasterCard and American Express** to which the client fully acknowledges the right of use.

PAYMENT NOTICE

Payment of invoices must be made in full. Any claims will be invalid after 15 days of receipt of the invoice.

No discount will apply regardless of advanced payment (Article 2 de la loi N°92-1442 du 31/12/1992).

CANCELLATION POLICY

No refunds will be issued in case of cancellation by the customer.

All requested and invoice services are considered agreed and definit.

The client will be liable for full payment of all services invoiced

FEES – INVOICING CHARGES

Except from customers « on account », we advise that failure to pay the landing fees in full at the Airport Reception Desk, an additional charge of 15.00 € excluding VAT will be added to the final invoice

SANCTIONS FOR LATE OR NON-PAYMENT

GENERAL PROVISIONS– DELAYS, DISPUTES AND LEGAL COSTS

Any invoice that hasn't been settled at the end of payment period, a reminder letter will be sent.

Penalties: In case of delays, non-payment or late payment; penalties of the current interest rate fixed by the European central bank plus ten points. will apply after a formal notice and without further reminders.

Legal costs recovery: A fixed payable fee of 40.00€ per invoice for recovery costs will be charged (Decree 2012-115 of 2-10-2012). However, if the recovery cost incurred exceeds the limit, additional compensation will be charged.

Litigation: In the event of non-payment on time and after sending a formal notice, the case will be referred to the litigation department. The debt collection costs and late penalties will be the responsibility of the Customer.

EXCEPTIONAL CLAUSES

CANCELATION OF BENEFITS AND SPECIAL DISCOUNT

AIDC may in the event of non-compliance with the legal deadlines for payment of invoices, cancel immediately and definitively any commercial advantage granted to the Customer. The cost occurred by external debts collectors will be added to the invoices in chronological order of issue.

TERMINATION OF CONTRACT

In the event of non-compliance by one of the parties of any of its obligations, the contractual relations may be terminated automatically by one or other of the parties, formal written thirty (30) working days' notice by registered letter with acknowledgment receipt that has not received a follow-up.

SEIZURE OF AIRCRAFT

AIDC reserves the right to oppose a Customer who is the object of a breach of the obligations of settlement, and implement measures of conservatory seizure in accordance with the legal provisions in force.

Article L123-4 civil aviation code :

"In the event of non-payment or insufficient payment of airport charges, handling charges or administrative penalties imposed by the Airport Control Authority, the Airport Operator or Administration Authority and Law Enforcement Authorities may, after prior written notice in attempts to obtain all settlement of invoices, repossess the aircraft as precautionary measure till payment of all debts has been settled by the customer.

The order of judgement enforcement is forwarded to the Air Traffic Control Authorities for the purpose of repossessing the aircraft. The customer is then notified of the judgement as well as the operator of the aircraft

The customer or the owner of the aircraft will be held liable for all legal costs occurred by such outcome.

Payment of the sums due shall result in the release of the aircraft. "

INTELLECTUAL PROPERTY RIGHTS

All use, copy or broadcast of all items covered by intellectual property rights is strictly prohibited without prior permission from AIDC.

PERSONAL DATA

The personal data is processed under the responsibility of the Castellet International Airport and is used for the management of air navigation management and control services as well as the other services provided for in the present GTCS, legal basis for processing. The recipients of this data are the Aéroport International du Castellet and its subcontractors located in the European Union. The data is kept for the duration of the contractual relationship and up to 5 years after its end.

In accordance with the applicable regulations, the Customer has the right to access, rectify, delete and port the data concerning them, as well as the right to oppose the processing for a legitimate reason, which they may exercise by contacting the data controller at the following email address : <https://www.aeroportducastellet.com/fr/contact/> or by mail to Aéroport du Castellet, RGPD, 3100 Route des Hauts du Camp 83330 LE CASTELLET (FRANCE).

Proof of identity may be requested prior to responding to the request and some requests may not be acted upon, such as if it would prevent the provision of services or meet a legal obligation.

The Customer is invited to first contact the Castellet International Airport amicably to exercise their rights, but they are informed that they have the right to lodge a complaint with the competent supervisory authority of their principal residence and in particular with the CNIL for French residents.

UNFORSEEN CIRCUMSTANCE

AIDC shall be exempt from any liability for any failure to perform its obligations in respect the terms and conditions of sale resulting from force majeure. Force majeure covers any other causes outside of AIDC's control as per article 1148 of the civil Code.

DISPUTES - TRIBUNAL –GOVERNING LAWS AND JURIDICTION - LANGUAGE

Any dispute, claim or execution in connection with GT&C is subject to French law.

Failure to resolve any dispute, the matter will be referred to The Commerce Tribunal of Toulon. In case of contradiction or misinterpretation or miss translation, only the French version of the GT&C will be upheld in resolving the matter between the two parties.

CLASSIFICATION OF AIRCRAFTS (EXCLUDING HELICOPTERS)

MTOW is specified on the navigation certificate of the Aircraft or on the Aircrafts register, **rounded to the next ton**. The weigh is referenced in metric tons, and the dimensions are in metric system.

EXCEMPTION FROM FEES

The aircrafts that meets one of the following conditions will not be subject to landing fees:

- All aircrafts on government mission carrying government personnel as per the Ministry of Civil Aviation 's Article
- All government Aircraft on technical missions, rescue and evacuation missions.

AIRCRAFTS FEES - DROP OFF PACKAGE PAX

The drop off packages price Pax only includes landing fees, beaconing, Assistance and towing with a limited parking up to one hour maximum for the drop off, extra charges will apply for all extra services.

The package tariff will apply upon first landing, in case of overstay of more than one hour, the daily package tariff will apply (as per page 9).

- Passengers on board returning aircraft due to technical problems or bad weather conditions
- Passengers on board an aircraft for technical stopover.
- Infants under 2 years of age.
